The appointee shall report to the office of the Deputy Director, Fire & Emergency Services Command Kulgam within a period of 21 days from the date of issuance of this order, failing which she shall forfeit her right to appointment and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointment of the appointee shall further be subject to the following conditions:

- a. The appointee shall be on probation for a period of two years.

- b. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- c. The appointment shall be subject to the outcome of Writ Petition(s), if any, pending before any competent court of law.
