

**ORDER NO: 511 (DF&ES) OF 2018**  
**DATED: 30 . 08. 2018**

The Hon'ble High Court at Srinagar on 09.08.2018 in SWP No.1474 titled Farooq Ahmad Beigh & Ors V/S State of J&K & Others, passed an order relevant portion of which is reproduced as under:-

..... "the order passed on 10.09.2015 in MP No. 01/2015 in SWP No. 1474/2015, is modified to the extent by providing that the department shall proceed for making promotions against the higher posts after considering the petitioners, however, no further promotion shall be made in favour of Respondents 5 to 17 and the promotions already made in their favour, shall remain subject to outcome of the writ petition"





In compliance to the above quoted directions, it is hereby ordered that promotions already granted vide above referred orders in favour of Respondents 5 to 17 detailed below, shall remain subject to outcome of Writ petition SWP No. 1474/ 2015 Titled Farooq Ahmad Beigh & Ors.
